**Trial:** Saturday, October 10, 8am and Sunday, October 11 at 8am in the Mustang Arena

### DIVISION RULES

1. **Sanctioning:** Tulsa State Fair Cattle Dog Trial will be sanctioned with the Central Cattle Dog Association and the National Cattle Dog Association.
2. **Trial:** The Tulsa State Fair Cattle Dog Trail is a time and point trial.
3. **Health Papers:** Dogs are required to have current health papers. Health papers will be checked upon arrival at Gate 7.
4. **CCDA Rules:** All CCDA trial rules will apply. All decisions by the trial director are final.
5. **Dog Limit:** There will be a limit of two dogs per handler per class.
6. **Open Class Limit:** Trial limit of 25 open dogs.
7. **Open Handlers:** All open handlers must meet at 7:30 am each day in the Mustang Arena.
8. **Conduct of Handlers:** ANY unsportsman like conduct may result in a disqualification.
9. **No Dogs Unattended:** No dogs are permitted to be left unattended.
10. **Dog Waste:** Exhibitors are responsible for picking up after their own dogs.
11. **Exhibitor Payouts:** Daily payouts will be calculated and paid after the event. Cattle charges and sanctioning fees will be withheld prior to calculating daily payouts.
